Updates:

Mayor Blankenship mentioned a project with Scott Park that the city has been working on. The city has received a grant from Kentucky League of Cities for upgrading new playground equipment at Scott Park. The city has also received a donation from the Lewis County Farm Bureau for handi—cap playground equipment at Scott Park. The city employees have put a new roof on the gazebo as well as poured new concrete under the gazebo. All these

renovations have been going on for the last couple of months, making it a great park for the kids to play.

Councilwoman Pugh ask to get an update on the Blighted, Abandoned and Deteriorated properties. She mentioned the home located on Front Street beside Councilwoman Patton. She stated the inside of the home is in bad shape. Chief Gilbert said he can only do what our ordinance states we can do. He mentioned he had gone today and drove by the home and everything outside looked ok. It is hard to go inside a residence without a reason. Councilwoman Pugh ask if we could get the State Fire Marshall involved in this. She mentioned that herself and pass Mayor Chris McGlone had met with a gentleman from Greenup County that would help us with the inspections here, but we would have to pay him. Mayor Blankenship stated he has appointed a city employee that is now the Zoning Coordinator, Floodplain Coordinator and will be able to do inspections for the city.


