DEMOLITION PERMIT APPLICATION FOR THE CITY OF VANCEBURG, KY

Instructions to Applicant: Complete application in full, and return with permit fee and any requested information.

Applicant is responsible for contacting all utility suppliers prior to demolition to arrange for the disconnection of all utility services. All building material and debris must be removed from the site, unless authorized to be buried onsite by the Building Inspector/Official. Basements, cellars and cisterns must be backfilled, the lot graded smooth and seeded or rocked. No material may be buried without obtaining a burn permit from the Vanceburg Fire Department. All debris removed from the site must be disposal of at a permitted landfill. Asbestos abatement regulations apply to all demolition of all structures, and all proposed demolitions are required to be reported by the owner to: **Department for Environmental Protection, Division of Air Quality, 803 Shenkel Lane, Frankfort, KY 40601, Phone 502-573-3382**
